GOLF COURSE

Designed by Robert von Hagge and renovated in 2014, our 18-hole championship golf course has challenging features that today's sophisticated player has come to expect. Robert von Hagge has designed some of the world's most award-winning courses. The course plays yardage from the tips and offers multiple sets of tees. The softly rolling fairways and mogul-crested topography beckon golfers of all levels of play as the course meanders along preserves.

Members enjoy outstanding practice facilities for driving, putting, chipping, sand practice and private lessons. The golf course is rated as one of the finest, most enjoyable in Florida.

LOCATION

Bay Colony Golf Club, situated on 120 acres of lush landscape bordering the Cocohatchee Strand Nature Preserve, located within the gates of Pelican Marsh community in Naples, Florida, less than two miles from the turquoise Gulf of Mexico waters and sandy white beaches that attract people to Southwest Florida.

CLUB FACILITIES

The striking Clubhouse with a contemporary coastal design received luxurious upgrades valued at more than \$10 million in 2017-2020, including updated men's and ladies' lounges, personalized wine lockers, and a refreshed Pro Shop. Equity Golf Membership



Bay Colony Golf Membership is exclusive to 300 Equity Golf Memberships to ensure a private, friendly environment and accessible club facilities for a privileged few. As per the club's Bylaws, thirty-three percent of these memberships may be non-resident members.

Golf Membership entitles the Member, their spouse and their unmarried children 23 years of age and under who are either living at home or attending school on a full-time basis to unlimited use of the golf course, practice facilities and Clubhouse. Members and spouses are provided with complimentary personalized lockers and complimentary bag storage.

Golf Members enjoy unlimited golf with complimentary greens fees, an active golf and social calendar, full use of the multiple Club dining venues, in-home custom catering, carryout service, private dining, and party and special events.

Golf cart or trail fees are applicable for Golf Members. Golf Members who own estate homes in The Estates at Bay Colony Golf Club have the privilege of owning a private golf cart for use on the Club facilities. Members receive reciprocal golfing opportunities at select area courses (May-October).

With limited availability, Bay Colony Golf Club offers an opportunity for applicants to become Bay Colony Golf Club Golf Members at an initiation fee lower than the Club's prevailing Equity Golf Membership initiation fee of \$300,000.

The Brokered Transfer Program permits the resale of memberships at a price determined by the selling member. Memberships are sold and transferred exclusively by the Club and in an order established by price, with the lowest price sold first.

Social Awaiting Golf...



Social Awaiting Golf Membership is a category of membership exclusively for awaiting the offering of an Equity Golf Membership. Social Awaiting Golf Membership entitles the Members to use of the Club's dining facilities, unlimited participation in the club's social special events, private dining, carryout service, in-season golf after 1 pm and unlimited summer golf (May-October).

Social Awaiting Golf Memberships include the Primary Member, their spouse and their unmarried children 23 years of age and under who are either living at home or attending school full time.

Social Awaiting Golf Members may golf after 1 pm in season (November-April) with complimentary greens fees. Golf cart or trail fees are applicable. During the off-season (May-October), Social Awaiting Golf Members enjoy unlimited golf and use of the off-season reciprocal program for golf and dining.

Social Awaiting Golf Membership has a non-refundable membership contribution of \$75,000. When you are able to acquire an Equity Golf Membership, your \$75,000 is applied to the purchase of that membership. Social Awaiting Golf Memberships are available exclusively to those who are waiting to acquire an Equity Golf Membership and are only available when no golf memberships are available for resale.

Mon-Equity Social Membership ...

Non-Equity Social Membership is a "standard" social membership which entitles the Member to full use of the Club's fine dining facilities, unlimited participation in Naples' liveliest social calendar, in-home custom catering, private on-site dining and meeting planning service, carryout service and <u>unlimited summer golf (May-October)</u>.

Social Memberships include the Member, their spouse and their unmarried children 23 years of age and under who are either living at home or attending school full time. Non-Equity Social Membership is limited to 50 Memberships.

Social Members may not use the golf course during season (November-April), except as the guest of a Golf Member, subject to all guest limitations and charges.

During the off season (May-October), Social Members may golf and use the practice facilities and will be charged cart and guest fees. Social Members also have the benefit of golf lessons with the Professional Staff year-round and have reciprocal dining during the off-season.

The holder of a Non-Equity Social Membership shall not be deemed an Equity Member and shall not have the right to vote or hold elected office.

The current initiation fee for this membership is \$30,000. Social Membership is an excellent choice for families who are interested in the exceptional Bay Colony Golf Club social lifestyle and fine dining but are not avid golfers.
